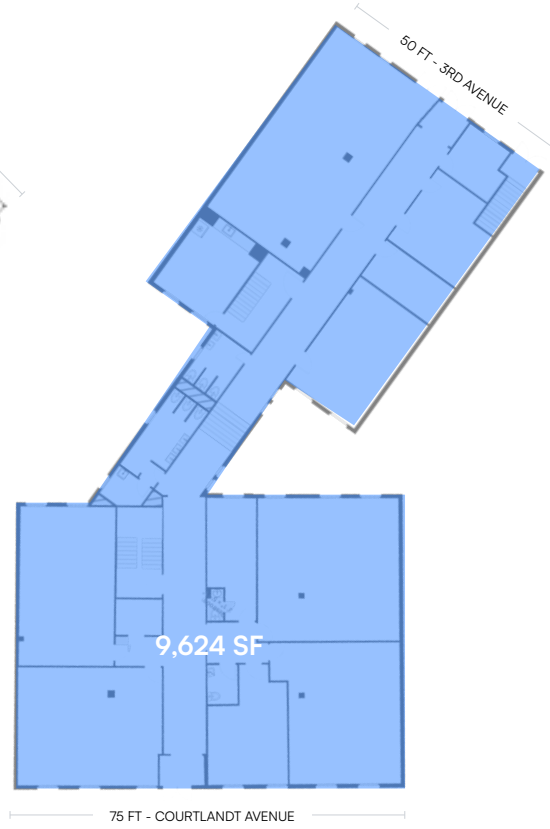

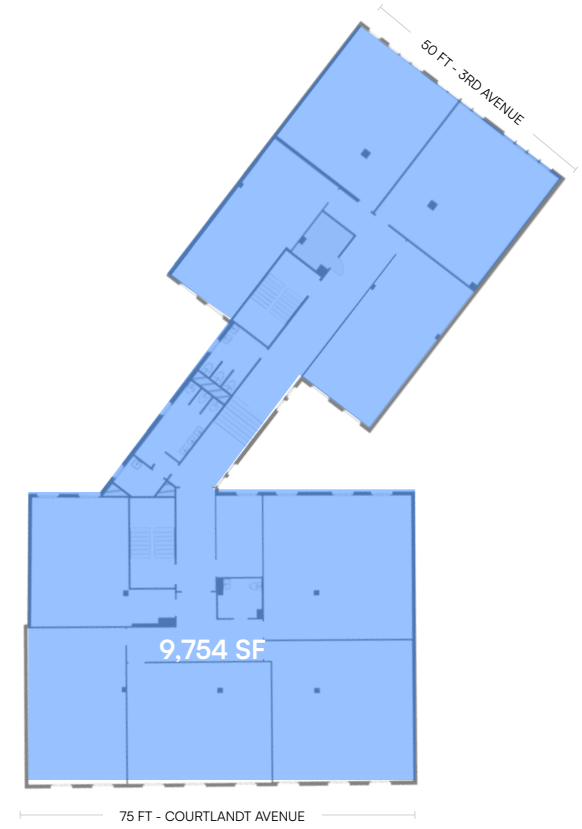
FLOOR PLANS

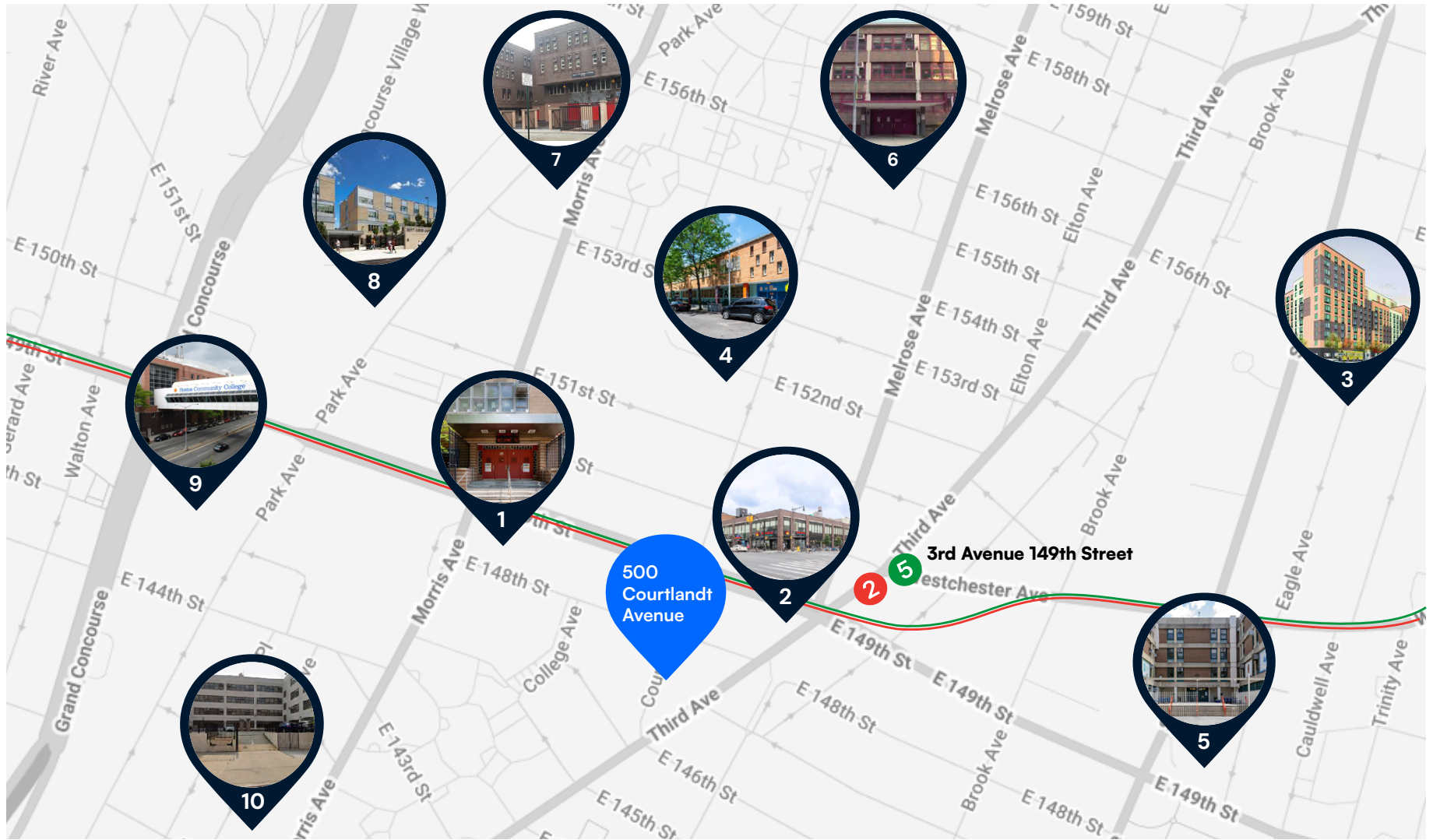

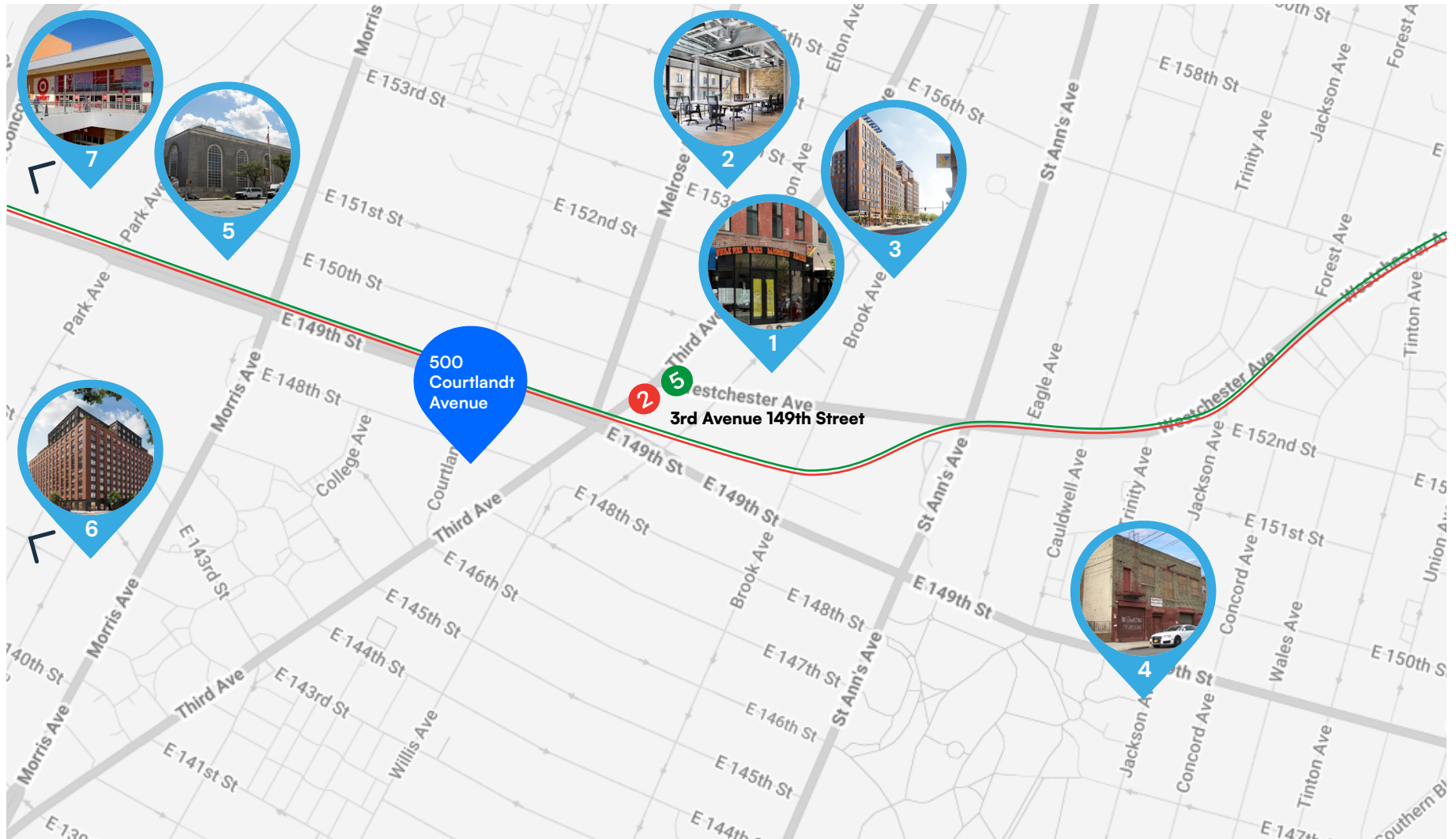

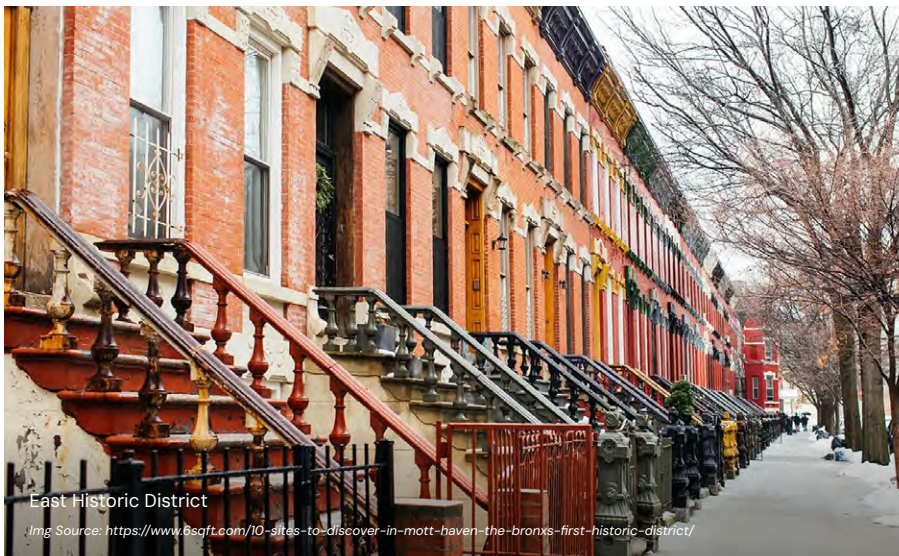
